KAMP-PRISK LICENSING GUIDELINES

- i) The Licensing Agent (LA) shall visit the premise of the user of sound recordings and/or audiovisual works (hereinafter referred to as 'the user') and introduce himself by displaying an official KAMP-PRISK badge. The LA shall furnish the user with supporting legal documentation on KAMP-PRISK's mandate and validity. The LA will then explain to the user in detail the requirements of the Communication to the Public License, the tariffs and shall further be available to answer any questions raised by the user.
- ii) The LA accompanied by the authorized contact person of the user shall proceed to take measurements of the premise(s) where applicable. Thereafter, the LA shall guide the user or authorized person in filling in the Enquiry Form with the required information and measurements. Having read and understood the contents, the user or authorized person shall affix their signature to the Enquiry Form as provided herein below.
- iii) The user shall be afforded time not exceeding three (3) days to verify and seek any legal or other clarification of the information given by the LA. After the said period, it shall be assumed that all queries have been attended to, unless otherwise communicated to the KAMP-PRISK secretariat or to the LA directly in writing.
- iv) The LA shall make a maximum of three (3) visits to the user's premise(s) within a total period of seven (7) days within which the user will be expected to confirm his intention to comply and obtain the Communication to the Public License. Failure to receive any communication from the user within the stipulated timeline shall be treated as noncompliance and the same shall lead to enforcement by KAMP-PRISK in accordance with the Copyright Act Cap 130, Laws of Kenya.
- v) Invoiced users shall have a period of seven (7) days to make payments on receiving KAMP-PRISK invoice duly signed by the Licensing Agent. Payment shall be made to the KAMP-PRISK Bank Account:

Please note that **CASH** payments are **NOT ACCEPTED** under ANY circumstances. All payments shall be made either through cheque, RTGS, EFT or M-Pesa (M-Pesa message should be provided as evidence of payment.)

vi) NOTE that the absolute minimum charge for sound recording (SR) is Kenya Shillings Two Thousand (Kshs. 2,000.00) and that of audio-visual (AV) is Kenya Shillings Three Thousand (Kshs. 3,000.00).
