INVITATION FOR COMMENTS AND FEEDBACK ON THE PROPOSED DISTRIBUTION RULES AND DISTRIBUTION CALENDAR FOR KAMP

The Kenya Association of Music Producers (KAMP) is developing Distribution Rules and a Distribution calendar for its members. The objective of Distribution Rules and calendars is to provide clear guidelines and timeliness when royalties shall be distributed. To achieve this objective the Board appointed a Taskforce to the rules.

The Memorandum and Articles of Association (MemoArts) require the Association to involve its members in the process of formulating Policies and Legal instruments by requesting and receiving views and opinions from the members before they are presented at the Annual General Meeting (AGM).

The Kenya Association of Music Producers hereby invites KAMP members to participate in this process through submission of views and/or comments on the two draft documents i.e. Distribution Rules and Distribution Calendar. **The documents are available and can be accessed through the KAMP's website at: www.kamp.ro.ke.**
